## A message from Alan Bakewell:

The 'Friends' have now been in existence since October 2001. Since then we have operated as an informal pressure group to lobby for environmental improvements in and about the reservoir and to act as a focal point for local consultations on future developments by the City. Whilst the initial thrust of the activities were directed at site clearance via a LILA supported scheme it now appears that future improvements might be possible when the reservoir and adjacent areas become a Local Nature Reserve (LNR). Let us remember that the achievements that the 'Friends' can be associated with include: -

- a) The re-establishment of an area of open water via a de-silting exercise;
- b) Publicity via the Ed Doolan radio programme, Metronews and Evening Mail;
- c) Community involvement through litter picking events;
- d) A site-planting scheme;
- e) Clearance of the former road to Burmans; and
- f) Comments on the draft 'Management Plan' for the LNR.

In order to achieve many of the items contained within the draft 'Management Plan' for the site (and possibly those associated with Merecroft Pool) the group will now need to deal proactively with the City Council and the urban Wildlife Trust. There is now a need for the FWR to move forward on a more formal basis. When the LNR status is eventually confirmed it is intended that we become the 'Friends of Kings Norton Nature Reserve'.

A new Committee was therefore formed at the recent EGM to represent the local community and support the proposed local nature reserve. The following have been elected:

#### *The Wildlife corner:*

May observations - Several noteworthy events throughout the month culminating with a good sighting of a Muntjac deer walking up Popes Lane on Sunday the 30<sup>th</sup>. A fox was also seen stalking around the reservoir.

The local bird population had mixed fortunes; the nests of Coot, Canada Geese and little grebe were all destroyed when the reservoir was flooded on X May. Better results at Merecroft where the geese and the Great Crested Grebe bred successfully. Mallard ducklings were present at both sites. Tufted Duck are occasional visitors and up to 3 Grey Herons have been reported at one time at Wychall and in the River Rea. The summer visitors are also here in numbers with many Blackcap, Whitethroat and Chiffchaff.

#### Latest News:

The proposal to designate the Wychall Reservoir and Merecroft pool areas as a local nature reserve (LNR) appears to be proceeding to plan. Information was contained in a paper presented to and approved by the Kings Norton Ward Committee on the 20 April. This information has now been sent by the City to all properties in the locality. The final report to the Ward Committee is planned for July with Cabinet Member approval in September. Those are the procedures the City Council needs to adopt as part of the formal process. The Management Plan should be finalised in August with the final English Nature approvals in October.

The designation as an LNR by English Nature will then protect the area and permit its development for nature conservation.
